(Revenue \$) RESEARCH: THE GASTRIC CANCER FOUNDATION IS THE PRIMARY SOURCE OF FUNDING FOR THE GASTRIC CANCER REGISTRY (GCR) BASED AT STANFORD MEDICAL CENTER. IT IS THE MOST COMPREHENSIVE AND LARGEST HIPAA-COMPLIANT REGISTRY FOR THIS DISEASE. THE GCR MAKES CLINICAL AND GENOMIC INFORMATION AVAILABLE TO ALL RESEARCHERS FREE OF CHARGE THROUGH ITS OPEN-ACCESS GENOME EXPLORER INTERNET PORTAL. IN 2020-2021 THE GCR EXCEEDED 500 ENROLLED PATIENTS AND EXPANDED ITS TUMOR LIBRARY TO OVER 300 SAMPLES. BEYOND THE GCR, THE FOUNDATION MADE TWO STRATEGIC ONE-YEAR GRANTS TO PROVIDE SEED-FUNDING FOR PROMISING STUDIES WITH THE POTENTIAL TO BRING NEW TREATMENTS TO PATIENTS.
